EXECUTIVE DIRECTOR'S REPORT

July 14, 2022

Directors,

As we begin FY 2023, I am disheartened by the current financial status of the organization, due mostly to the lack of execution of a contract for the Peer Recovery Credential project with the DMHAS Office of Recovery Community Affairs after meeting all of our deliverables for the past year with the promise of remuneration. Although implied, but not directly stated, it stems from a bureaucratic error — delay of over 6 months in submitting completed document to DMHAS contracting. I have spoken with both the new director of ORCA and the Commissioner in the last week with a promise of prioritizing efforts to get this executed. In addition to the initial \$51,000 expected at execution in FY 2022, it hampered our ability to market the CPRS credential to the recovery community as awareness of the to-bedeveloped credential among potential candidates is widespread. Given the present situation, we have removed ourselves from any efforts on the project with a commitment for a full return upon contract execution. Both ORCA Director Elsa Ward and Commissioner Navaretta have expressed an understanding of our decision.

Additionally, Margaret O'Hagan-Lynch, our contract administrator for our 3-year PSA for FYs 23-25 reports that the contracts sits with the attorney general. She is aware that we are currently operating without a contract or any DMHAS funding and the risk that it creates.

In other news, the feedback from those in attendance at the conference has been especially positive regarding both the venue and the slate of presenters. Addressing the less-discussed topics that we selected provided lots of new information for attendees (I have heard many comments about the new understanding that gut health plays on mental health) and people were able to connect/reconnect with other professionals. Having a positive income over expenses number is always appreciated.

We are developing a peer support virtual training program with the assistance of TPN.Health, our virtual training partner, which could provide some positive income for the CCB, and are considering doing the same with a clinical supervision focus. We have established ourselves as an effective training organization through TPN, it is now time to monetize what we do with them. We also have been invited back to speak at the Addiction Professionals of North Carolina Fall Conference in Wilmington in mid-October and to deliver a plenary during the California Addiction Conference in San Diego later in that month. Each comes with a small honoraria and reimbursement of travel expenses.

Scott continues to represent the CCB at meetings of our regional caucus (New England, NY and NJ) for the IC&RC, keeping us informed and aware of what is occurring with our sister boards across the globe. The IC&RC continues to struggle with the fallout from the previous director's unethical and irresponsible actions, much of which we were sharply attacked for predicting, given the behaviors witnessed, and some even beyond the scope of what could be imagined. We continue our involvement as Scott provides all of our required deliverables to their admin, but we have adopted a more passive role than we have in the past – with hopes that the issues that remain evident are addressed. We are contractually bound by DMHAS to remain a part of IC&RC, but we are not required to work on IC&RC projects, of which we have a strong history.

We have 2 candidates for positions on the Board, At the time of this writing, President Amy Sedgwick and I have an interview with Jaya Daptadar, COO of Bridges in Milford, scheduled after the time of this writing, so I am not comfortable offering feedback in this format. We also have an incredibly strong candidate in Eileen Russo, recently retired as the Director of the DARC program at Gateway CC in New Haven. Eileen is well known to many of us at the CCB and throughout the professional community here in Connecticut, with significant expertise in Trauma Informed Care. Most importantly. Eileen also serves on the Executive Committee of the Connecticut Association of Addiction Professionals (CAAP), the state affiliate of the National Association for Alcoholism and Drug Abuse Counselors (NAADAC), which represents the interests of the professionals in the workforce. We have tried (and failed) several times over the years to form a workable understanding with CAAP (related to both national and state workforce politics), but Eileen's candidacy suggests a change in their organizational attitude. Any relationship can be beneficial to both organizations (including monetarily) and to those who work in the field.

I would like to thank Nicole Hampton for attending and for taking an active part in the Connecticut stop of the national *Living Undeterred Tour* at the University of Bridgeport on Saturday, July 2. The organizer of the tour is a layperson who although has lived experience, often uses common, yet inappropriate, terminology regarding SUDs – Nicole expressed some discomfort with the language used and was able to turn it into a teaching moment for the organizer, who has committed to using less stigmatizing language. As 5 more weeks remain on this national tour, the CCB has, in a concrete fashion, helped change the dialogue around mental health and substance use disorders!

Treasurer's Report

July 14, 2022

At the conclusion of FY 2022, the CCB posted an income of \$299,748 with expenses of \$336,639 for a total loss of \$36,891 (numbers prior to accountant review and changes). I expect concern to be raised by our accountant, which may be allayed somewhat by the accounts receivable for the fiscal year of \$52,300 (putting us, in effect, at +\$15,409). Any other assets and liabilities, along with final numbers, will be available following the completion of the IRS-990.

The overwhelming part of the total accounts receivable comes from the Office of Recovery Community Affairs at DMHAS, whose failure to file the Peer Credentialing contract in a timely manner, thus creating significant delays in the initial payment of \$51,000. At present, we are also waiting on execution of our latest 3-year contract with the expected value of \$391,500 paid in 12 quarterly increments of \$32,625. Both individuals at DMHAS who oversee the specific contracts are aware of, and working on, resolving both issues.

This puts us in an extremely difficult cash position at present. We are presently working on motivating those approved candidates who have yet to register for the examination to make payment, as well as reaching out to those with lapsed credentials, encouraging them to renew. At present, we are paying only the most urgent of our bills initially, and working on delays or partial payments where we can. This is a short-term solution only, as we have not held any delayed significant accounts payable for 10 years. The possibility of application for a line of credit through our financial institution is also available.

Creating revenue and fundraising opportunities for the CCB is no longer an option, it is a requirement. Our DMHAS funding level has not changed since 2009 and has lost 40% of its actual purchasing power (nearly \$52,500). Fees have been raised in the past 3 years, so passing any other increases on to our professionals and candidates is risky. We will need to raise \$50,000 to offset the loss of purchasing power. I implore you all to focus on ideas coupled with actions – the latter cannot be ignored. We must, as an entire group, be reminded of the overall fiduciary responsibility collectively and individually held. These are desperate times.

On a more positive note, the conference brought in over \$21k, significantly more than we have ever earned from an event. We did have over \$18k in expenses, also the highest ever, but there are lessons learned and opportunities for increased income. Thanks to all for attending and participating in our process.

Ethics Committee Report

July 14, 2022

On June 6, 2022, the CCB received an ethics complaint against Betty Brown, CIT #6930 alleging that a violation of Rule 5.5 has occurred:

"A certified professional shall not perform services outside of his or her area of training, expertise, or scope of practice."

The complaint alleged that the respondent was advertising in Psychology Today as a provider with expertise in over 38 areas, including sexual abuse, trauma and PTSD, and Borderline Personality Disorder. A screenshot of the advertisement was included as supporting evidence. The Executive Director determined that there was sufficient evidence provided to warrant referral to the Ethics Committee.

After reviewing and verifying the evidence, the Ethics Committee Chairperson interviewed the respondent to allow for a response to the allegations. The respondent was unable to provide any evidence to support her claims of expertise. She also did not seem to grasp the risk to public health involved in such claims. She did report that the advertisement would be immediately removed. At the time of this writing, the advertisement was still actively posted online: https://www.psychologytoday.com/us/therapists/betty-brown-hartford-ct/975139.

The evidence provided supported the claim of violation of Rule 5.5. In lieu of revocation of the credential, the sanctions applied will be: 20 hours of Ethics-specific training, including no less than 5 hours specific to defining and adhering to one's scope of practice (the CIT verifies NO specific competency, serving simply as a starting credential to begin working towards a reciprocal credential), that must be completed in one year; revocation of the respondent's ability to sit for the IC&RC ADC examination as a CIT, and; immediate removal of the advertisement on Psychology Today website.

Should the advertisement be visible in 7 days (July 21, 2022), then the respondent's credential will be revoked and no further credentials can be attained without satisfactorily meeting with the Ethics Committee of the CCB.

EXAM SUMMARY - Fiscal Year 2022

Data concerning the number of candidates who pass the exam and number of new certifications issued will often not be identical. This is due to several factors, including Board policy to allow individuals who hold the Counselor In Training (CIT) credential to take the standardized exam without meeting all other requirements for certification (their certification will become effective in future years once all minimal standards have been met), and CITs who have passed the exam in previous years completing all requirements and becoming certified in this fiscal year. In practice, it is possible in any given fiscal year to have either more applicants passing the test than becoming certified or vice versa.

The exam data identifies the overall pass rate and provides a detailed breakdown of those who passed the exam and their associated pass rate percentages as well as a detailed breakdown of those who failed the exam and their associated pass rate percentages per domain. For example, during April – June 2017 for the Addiction Counselor exam – Form 13, there were a total of 12 test takers. Out of those 12, 10 passed the exam for an overall pass rate of 83.33 %. For the 'Screening, Assessment, and Engagement' domain, the 10 who passed the exam averaged a 68.62% pass rate for that domain. For the 2 who failed the exam, the average pass rate for that domain was 63.79%. The percentage rates for each domain are the average in that domain for all who passed (left column) and then the same for those who failed (right column).

Recommendations on trends, issues and needs of DMHAS workforce development Fiscal Year 2022

The CCB, having earned the reputation of being thought leaders in the SUD prevention, treatment and recovery industry across our country, has afforded us the unique opportunity to have ongoing consult and conversation with administrators, practitioners, and researchers about trends and needs of our workforce. Although our state is far ahead of others in terms of workforce competency, much of what needs to be addressed is universal. A summary of those needs follows:

- Supervision of peers: In the field, we are seeing those with clinical backgrounds and roles providing supervision of peer specialists which creates a risk of those individuals becoming clinical supports as opposed to supporting the recovery of clients. There has been significant fear of the role of peers being co-opted by agencies for their needs and establishing training guidelines for the development of true peer supervision. The role of peers can often be an ethical minefield, and trained supervisors are necessary. We are aware that here in Connecticut, CCAR has a "coachervision" training that suits there needs, but other options should also be available. In the state of Oregon, a model of peer supervisor competencies has been developed through a research-based process, for example.
- Clinical supervision improvements: Often times, individuals are placed in clinical supervision positions for reasons unrelated to the competencies of a supervisor:
 - They are outstanding clinicians;
 - They manage difficult caseloads;
 - o Thrust into the position due to longevity and attrition, and;
 - They are licensed and have the ability to sign off on clinical documents.
- The reality is that many individuals in the position have received little or no training on clinical supervision, and research by Dr. Carol Falender of UCLA and Pepperdine University shows that the quality of clinical supervision affects client outcomes. More training and support for those in clinical supervision positions, or for those desiring to hold that role, is necessary.
- We know clearly that the therapeutic relationship is a significant factor in clinician effectiveness as proven by research (Scott D Miller, et al, among others), so ongoing training to improve skills is an important need.
- Clinicians are all well aware of the term "Evidence Based Practice" as the field has focused
 on them for several years. Our colleagues around the country are reporting issues that are
 also not uncommon here: the view of using evidence-based practices as a potential
 panacea, without understanding the limitations related to appropriate populations,
 community and other factors. It is believed that to be used effectively, a deeper
 understanding of EBPs would be beneficial.

• It is without question that harm reduction interventions have been shown to save lives, and more training opportunities to expose professionals to these techniques are essential. The main tenet of harm reduction is that all lives have value and are worth saving, and true harm reduction programs meet people where they are at, without placing the expectation of seeking recovery on all recipients. This mindset often can be troublesome for those in the recovery space to grasp or accept, as it falls outside of not only the training we may have received, but also against a general community standard. Exposing those in the field to this information is paramount.

I would be remiss to not mention a growing theme in the field that is emerging in the face of treatment center and referral source claims of success without outcome data to support it. The field has struggled with the idea of outcomes for decades, measuring such things as number of visits, ongoing 12 step fellowship attendance, positive statements from program alumni, and other amenities. Goals achieved are often program related and not client driven – so there is a growing need for clinicians and programs to understand the importance of true & proximal outcomes – a measurement of what the client wishes to achieve from the episode of care.

Thank you for allowing us this opportunity to offer this discussion on workforce training needs for the upcoming fiscal year.
