A 501(C)(3) organization is a UNITED STATES CORPORATION, TRUST, UNINCORPORATED ASSOCIATION OR OTHER TYPE OF ORGANIZATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501(C)(3) OF TITLE 26 OF THE UNITED STATES TAX CODE.

26 U.S.C. § 170 PROVIDES A DEDUCTION FOR FEDERAL INCOME TAX PURPOSES, FOR SOME DONORS WHO MAKE CHARITABLE CONTRIBUTIONS TO MOST TYPES OF 501(C)(3) ORGANIZATIONS, AMONG OTHERS.
